

**Terms and Conditions governing the OCBC Titanium Rewards Catch Cart Campaign (“Promotion”) from 19 September to 30 September 2018 (“Promotion Period”)**

**Eligibility**

1. This Promotion is open only to (“Qualified Cardmembers”) existing principal cardmember of the OCBC Titanium Rewards Card who has received an SMS from Oversea-Chinese Banking Corporation Limited (“OCBC Bank”), inviting them to participate in this Promotion.

**Participation**

2. To participate in this Promotion, Qualified Cardmembers must play the game contained in the URL in the SMS sent by OCBC Bank and successfully submit their scores via [bit.ly/catchcart](http://bit.ly/catchcart) by 30 September 2018 at 11:59pm.

**Prizes**

3. Subject to these terms and conditions and at the end of the Promotion Period, the first 50 Qualified Cardmembers with the highest scores will receive the following Prizes:

11 - 30	25,000 OCBC\$

4. In the event that there are multiple scores tied for a ranking, the Qualified Cardmember with the earliest submission will be given precedence.

For example, where Customer A has submitted a score of 10 at 10:00am on 19 September 2018 and Customer B has submitted a score of 10 at 2:00pm on 19 September 2018, Customer A will take precedence over Customer B in ranking due to earlier time of submission.

5. While the game may be played more than once, only the highest score submitted from each Qualified Cardmember on [bit.ly/catchcart](http://bit.ly/catchcart) will be taken into account. The relevant Masked NRIC from your submission will be placed on the leaderboard.

6. The information collected from your score submission will be used to display the top 50 scorers on the leaderboard. Both the score and masked NRIC number will be used.

9. Qualified Cardmember's Card account must be active and in good standing during the Promotion Period and at the time of crediting of the Prize.

10. OCBC Bank reserves the right in its sole and absolute discretion to determine whether a submission qualifies as a valid submission under this Promotion. If OCBC Bank in its sole and absolute discretion decides that any submission is not to be considered a valid, the Prizes will not be awarded.

OCBC Bank reserves the right to change or substitute the Prizes with any item of similar value and/or vary, to delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any Qualifying Cardmember and the dates of the Promotion. OCBC Bank's decision on all matters relating to this Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank.
