Terms & Conditions Governing the OCBC Revolving Term Loan Drawdown Promotion (the "Campaign")

Campaign Period

1. This Campaign period shall run from **18 November 2024** to **31 December 2024** (both dates inclusive), or such other periods(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("**OCBC Bank**") at its absolute discretion (the "**Campaign Period**").

Eligibility

- 2. You will qualify for the Campaign if:
 - i. you have received an invitation from OCBC Bank to participate in this Campaign. For avoidance of doubt, the invitation to participate in this Campaign is not transferrable;
 - ii. all your OCBC Accounts are in good standing for the entire duration of the Campaign Period;
 - iii. you have an existing OCBC Revolving Term Loan facility for the entire duration of the Campaign Period; and
 - iv. you perform at least 1 Eligible Drawdown (as defined in clause 3 below) on your Revolving Term Loan within the Campaign Period.

(collectively, "Eligible Customer").

Definitions

- 3. For the purposes of this Campaign and these terms and conditions:
 - **"Eligible Drawdown"** refers to any successful drawdown of at least S\$20,000 on the OCBC Revolving Term Loan facility which drawdown is credited to an OCBC Account.
 - "OCBC Account" means a Singapore dollars current account held by the Eligible Customer with OCBC Bank.

Campaign Mechanics

- 10. OCBC Bank reserves the right to substitute or replace the Reward with any item of similar value at its sole discretion without notice to any person.

General

- 11. The eligibility of any Eligible Customer to participate in this Campaign and/or receive any Reward shall be determined at the absolute discretion of OCBC Bank.
- 12. OCBC Bank reserves the right at its absolute discretion to terminate the Campaign or vary, delete, or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any customer and the dates of the Campaign.
- 13. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Campaign, or any product and/or service relating to the Campaign. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Campaign, and/or the use of any product and/or service relating to the Campaign, by any person.
- OCBC Bank's decisions on all matters relating to the Campaign shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Campaign, these terms and conditions shall prevail.
- 15.
