

Terms and Conditions Governing OCBC MyOwn Debit Card Cashback Promotion for Existing Customers (Feb 2025 – Apr 2025)

1. Eligibility

- 1.1 You will be eligible for the Promotion (the 'Eligible Customer') if:
 - a) You are an Existing OCBC MyOwn Account holder before 19 February 2025; and
 - b) Your OCBC MyOwn Account (the "Account") is active and in good standing with OCBC Bank during the Promotion Period.

2. Promotion Periods

2.1 This Promotion will take place across 2 Promotion Periods between 19 February 2025 to 30 April 2025.

Period 1	19 February to 31 March 2025
Period 2	1 April to 30 April 2025

3. Promotion Mechanics

3.1 An Eligible Customer shall be entitled to S\$1 cashback for every 3 transactions of at least S\$5 each made across selected merchants from the following Categories for each of the Promotion Period ("Eligible Transactions"); refer to the table below for the Eligible Merchants of this Promotion.

3.2 The 3 Eligible Transactions may be made in any combination across any of the 3 categories. Sample illustration:

Eligible Transactions made at Merchants from Selected Categories	Cashback received
 1 transaction on merchant from Movies 1 transaction on merchant from Food and Beverage 1 transaction on merchant from Books and Stationery 	S\$1
3 transactions on merchants in the Food and Beverage	S\$1
 2 transactions on merchants in the Food and Beverage 1 transaction on Books and Stationery 	S\$1

3.3 There is a limit of S\$20 cashback that each customer can receive in each Promotion Period. Each transaction must be at least S\$5 and be in Singapore Dollars.





- a) i.e. if a customer makes 18 Eligible Transactions in one of the Promotion Period, they are eligible for \$\$6 cashback.
- b) However, if a customer makes 63 Eligible Transactions in one of the Promotion Period, they will receive a maximum of S\$20 cashback.
- 3.4 The cashback will be credited into Eligible Customer's OCBC MyOwn Account by **31 May 2025** if the customer meets the criteria set out in 3.1, 3.2 and 3.3.
- 3.5 A transaction will be determined by its transaction date based on Singapore Timing (UTC+08:00) and must be posted for the spend to be qualified. For avoidance of doubt, the date which the transaction is submitted or posted may differ from the actual date the transaction was made, and OCBC Bank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion.
- 3.6 OCBC Bank reserves the right and at any time at its absolute discretion and without giving any reason or notice to withdraw, clawback, cancel and/or invalidate any cashback awarded to customer without liability. A customer will not be entitled to any payment or compensation whatsoever in respect of such withdrawal, clawback, cancellation or invalidation.
- 3.7 The eligibility of any Eligible Customer to participate in this Promotion and/or receive and additional cashback shall be determined at the absolute discretion of OCBC Bank.

4. General
