

## TERMS AND CONDITIONS GOVERNING THE 2.5 VOYAGE MILES DINING PROMOTION (“Promotion”)

### Promotion Period

- The promotion period shall run from 1 to 31 August 2020 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited (“OCBC Bank”) at its absolute discretion (the “Promotion Period”).

### Eligibility

- You will qualify for the Promotion (“Eligible Cardmember”) if:
  - You are an OCBC VOYAGE, OCBC Premier VOYAGE, OCBC Premier Private Client VOYAGE or OCBC Bank of Singapore VOYAGE cardmember (“VOYAGE card”); and
  - you have made dining transactions during the Promotion Period on your VOYAGE card.

### Definitions

- For avoidance of doubt, dining transactions made under the below Merchant Description Code (“MCC”) will qualify:
  - MCC 5811: Caterers
  - MCC 5812: Eating Places, Restaurants
  - MCC 5814: Fast Food Restaurants

### Promotion Mechanics

- 2.5 VOYAGE Miles will be awarded per S\$1 spent on dining transaction, capped at the first S\$1,000 spent.
