

Terms and Conditions Governing the BEST Denki 2021 11.11 Online Sale for OCBC Credit Card ("Promotion")

Promotion Period

 The promotion period shall run from 10 November 2021 to 15 November 2021 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

Eligibility

 - I. you are an existing holder of an OCBC Credit Card (defined below);
