

# Terms & Conditions Governing the OCBC Rewards Card Fly with OCBC\$ Campaign (the "Promotion")

### 1. Promotion Period

The promotion period shall run from 2 August 2024 to 30 September 2024 ("Promotion Period") (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Periods").

## 2. Fly with OCBC\$

- 2.1. To enrol in the Promotion, SMS 72 377 with: RWKF <space> Last 8 digits of your Card no. E.g. RWKF 12345678.
- 2.2. Existing principal holders of the OCBC Rewards Card ("Card") who pay \$\$436.00 (including GST) will qualify for this Benefit ("Qualified Cardmembers").
- 2.3. Under this Benefit, the Qualified Cardmembers who qualify for this Benefit will be able to subscribe to and receive 50,000 OCBC\$ once payment has been received by OCBC Bank for S\$436.00 (including GST).
- 2.4. Qualified Cardmembers understand and agree that OCBC Bank may take up to 14 workings days from the date it receives the Qualified Cardmember's valid enrolment to process and award the Benefit. Notwithstanding anything stated herein, OCBC Bank shall not be liable for any delay in the process for any reason whatsoever (including without limitation, delay due to incorrect information in the system or due to system constraints and errors). Urgent requests or cancellations will strictly not be entertained.
- 2.5. Qualified Cardmembers are aware the terms and conditions of Krisflyer miles redemption program (clause 5 of Rewards Programme Terms and Conditions at <a href="https://internet.ocbc.com/rewards/Terms">https://internet.ocbc.com/rewards/Terms</a>) will still apply and agree to be bound by the said terms and conditions.
- 2.6. Refund of S\$436.00 (including GST) shall not be entertained or allowed.
- 2.7. OCBC\$ will expire on the last day of the 24th calendar month calculated/commencing from the relevant calendar month in which such OCBC\$ was credited.

Date OCBC\$ was credited	Expiry date of credited OCBC\$
20 August 2024	31 August 2026
10 September 2024	30 September 2026

2.8. Any OCBC\$ accumulated but not utilised will be automatically forfeited, cancelled and shall become null and void at the relevant OCBC\$ expiry date or upon the termination of the relevant Card account, whichever is earlier.



2.9. All OCBC\$ that have expired will not be reinstated.

### 3. General

- 3.1. The benefits made available to Qualified Cardmembers pursuant to the terms of the Benefit are not exchangeable or refundable for cash, credit or kind.
- 3.2. OCBC Bank shall have the right to use agents, contractors or correspondents or any other third party as it deems appropriate in its sole and absolute discretion to administer and/or implement the Benefit and OCBC Bank shall not be liable to any person for any act, omission or neglect on the part of such agents, contractors, correspondents or third parties.
- 3.3. OCBC Bank reserves the right to suspend, withdraw or terminate the Benefit at any time without notice. The decision of OCBC Bank on all matters relating to the Benefit shall be final, binding and conclusive on all customers, including without limitation, any decision on the eligibility of any person to participate in this Benefit.
- 3.4.
