

Terms and Conditions Governing the Issuance of Vouchers with OCBC 365 Credit Card and OCBC Rewards Card at the Watsons Get Active event (The “Activity”)

Activity Period

1. The Activity shall be held on 9 November 2024 from 8am to 6pm at Fort Caning Green or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited (“**OCBC Bank**”) at its absolute discretion (“**Activity Period**”).

Activity

2. During the event, there will be a claw machine containing 100 capsule balls. Each participant will be entitled to one chance to play the claw machine if they qualify for the Activity.

Eligibility

3. You will qualify for the Activity (“**Participant**”) if:
 - Participants who make a purchase of any products at this event and pay using any OCBC card.
 - Participants who do not have an OCBC credit card but sign up for one at our booth.
