

## Terms and Conditions Governing the OCBC CNY Cash Reward Promotion (the "Promotion")

## **Promotion Period**

1. The promotion period is from 15 January 2025 to 28 March 2025 (both dates inclusive) ("Promotion Period"), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC").

## **Eligibility and Promotion Mechanics**

- 2. A customer ("Eligible Customer") will qualify for a cash reward ("Reward") under this Promotion if
  - (a) he/she has successfully applied for refinancing of an existing Private Home Loan from another financial institution to OCBC during the Promotion Period;
  - (b) the Private Home Loan is at least \$\$1,000,000 (excluding bridging loan);
  - (c) the Private Home Loan is applied directly with OCBC or referred by property agent registered with both the Council for Estate Agencies and OCBC; and
