

Terms & Conditions Governing the Watsons ION Store Opening Promotional Campaign (the "Promotion")

1) Promotion Period

- (a) The promotion period shall run from 6 June 2024 to 19 June 2024 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").
 - i. The Voucher issuance period shall run from 6 June 2024 to 19 June 2024, both dates inclusive ("Issuance Period").
 - ii. The Voucher redemption period shall run from 6 June 2024 to 30 June 2024, both dates inclusive ("Redemption Period").

2) Eligibility

- (a) You will qualify for the Promotion ("Eligible Cardmember") if:
 - i. you hold an OCBC Credit Card or Debit Card ("Card");
 - ii. your OCBC Credit Card and Debit Card account is active and in good standing with OCBC Bank during the Promotion Period until the point of fulfilment.

3) Promotion Mechanics

- (a) Eligible Cardmembers who meet the conditions specified herein will receive the Voucher specified in the Invitation, subject to these terms and conditions.
 - i. The Promotion is only available to Eligible Cardmember who makes any transaction at the Watsons store located at 2 Orchard Turn #B4-12 ION Orchard, Singapore 238801 ("Watsons ION Store").
 - 1. Every 6th customer who charges their OCBC Card at Watsons ION Store during the Issuance Period will receive a S\$10 Watsons return voucher ("Voucher") at the point of sale.
 - 2. To use the Voucher, the customer must make a minimum spend of S\$60 in a single transaction on the return visit to the Watsons ION Store during the Redemption Period ("Voucher Redemption").
 - ii. The Promotion is limited to the first 1,500 Voucher Redemptions that meet the conditions set out above.
- (b) The Voucher can only be used for in-store purchases at Watsons ION Store. It cannot be used for online purchases or purchases at any other Watsons store.
- (c) Only one (1) Voucher can be used per transaction. Multiple vouchers cannot be combined.
- (d) The Voucher can be used in conjunction with other promotions, discounts or offers. However, it may not be used with other vouchers in the same transaction.

4) General

- (a) The eligibility of any Eligible Cardmember to participate in this Promotion and/or shall be determined at the absolute discretion of OCBC Bank.
- (b) OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any customer and the dates of the Promotion.
- (c) OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
- (d) OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions

and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.

- (e) OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
- (f) By participating in this Promotion, the Eligible Cardmember hereby agrees and consents to the collection, use and disclosure of their personal data by OCBC Bank and its related corporations (collectively, "OCBC Group") for the purposes of managing and administering this Promotion, and such other related purposes, in accordance with OCBC's Data Protection Policy (which can be accessed via the OCBC website > Personal Banking > Policies).
- (g) These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
